

Chablais 300 Terms & Conditions

The Chablais 300 is a single stage ultra-distance cycling event that takes place in the Haute Savoie Region of France and the Valais Canton of Switzerland from the 20th to the 22nd of September, 2024, henceforth referred to as “the Event.”

Agreement Between Parties

- **The Organiser:** Chablais 300, known within this document as “the Association” is a legally recognised non-profit organisation under the 1901 French law, with the registration number W744007189. The Association's principal office is located at 20a Chemin de Ressachaux, 74110, Morzine, France, and it is responsible for coordinating the Event.
- **The Participant:** Any individual registering for the Event, whose personal and contact information is provided during the registration process, will be acknowledged as “the Rider.”

Registration

- The Rider consents to join and partake in the Event, adhering to these Terms and Conditions, the Rider Agreement, and the Event Rules.
- The Rider commits to fully comply with the aforementioned agreements and any decisions made by the Association or the Event Directors, including any measures to discontinue the Rider’s participation in the Event.

Rider's Responsibilities & Conditions for Participation

- Riders must be at least 18 years old by September 20, 2024.
- The Rider assures that all information provided to the Association, including previous cycling experience, is truthful and accurate.
- The Rider confirms their excellent health status and acknowledges no known conditions that would prevent participation in the demanding and lengthy Event.
- The Rider is conscious of the inherent risks, including potential severe injuries or death, due to the mountainous terrain and the nature of cycling events.
- The Rider acknowledges the Association's limited role in providing assistance for physical, technical, or mental challenges faced during the Event, accepting all risks associated.
- Riders are responsible for their bicycle and gear, ensuring everything is suitable for the Event's demands and adhering to mandatory equipment guidelines and any additional recommendations by the Association.
- The Rider will follow all directives provided by the Event Directors.

- The Rider is aware of the risks associated with cycling in traffic and potential encounters with wildlife.
- The Rider commits to a self-supported approach, understanding the prohibition of inter-rider assistance, except in emergencies.
- Helmets are strongly recommended, with Riders choosing not to wear one doing so at their own risk.
- Riders are required to secure appropriate insurance for the Event, covering all potential risks, and provide proof of insurance to the Association.
- The Rider acknowledges that specialist medical care may not be readily available, with insurance needing to cover possible medevac costs.

GPS Tracking and Route Compliance

- Riders are accountable for GPS trackers provided by the Association, with an obligation to return them in working condition or face replacement fees of up to €150
- The Event's designated route must be strictly followed, with Riders keeping evidence of their journey for verification purposes.

Withdrawal, Cancellation, and Refunds

- Notice of withdrawal must be communicated to the Association, with Riders responsible for their departure from the Event.
- A refund of 50% is available for cancellations before July 1, 2024.
- The Association reserves the right to cancel or alter the Event, with changes communicated at least two weeks prior to the start date. No refunds will be issued for cancellations due to force majeure or other uncontrollable circumstances.

Media and Intellectual Property

- By entering the Event, Riders grant the Association rights to use any media captured during the Event for promotional purposes without compensation.
- The Association holds exclusive rights over the Event's intellectual property, including images and branding.

Modifications and Jurisdiction

- The Association may update Terms and Conditions, the Rider Agreement, and Event Rules as necessary, with changes becoming binding upon notification.
- This Agreement is governed by French law.
